PROJECT RED CORD CONTINUES COMMUNITY ANTI-TRAFFICKING EFFORTS

For 17 years, Renee Jones has used respect and support to empower women struggling with homelessness or prostitution. Renee has organized Project Red Cord Night Out, a community street outreach series, on Lorain Avenue since June 2018. Her Renee Jones Empowerment Center has moved from West 65th Street to 3764 Pearl Road, to increase its space and capacity, but the Center's work continues to focus on Lorain Avenue in the Detroit Shoreway neighborhood.

Project Red Cord was created in direct response to concerns from neighborhood residents. Project Red Cord also engages residents to understand what human trafficking is (and isn't) and how to help. An educational event, **kNOw Human Trafficking**, will be open to all on Thursday, April 16, 6-8pm at Urban Community School (4909 Lorain Avenue).

Project Red Cord Night Out will return at West 73rd Street and Lorain Avenue on Fridays, starting April 24 and May 29, at 6pm. Services evolve to meet the community's needs and have included free food, hygiene products, Narcan and Naloxone kits. and more. 
